Executive Summary

The national Board of Revenue is the top most customer of Oracle considering Government sector of Bangladesh.


National Board of Revenue (NBR) is the central authority for tax administration in Bangladesh. It is under the Internal Resource Division of Ministry of Finance. NBR is the authority for tax policies and tax laws in Bangladesh.


The automation of Bangladesh Customs Administration in the NBR began in the early 90s. An automated system called ASYCUDA was implemented in 1993.

The system is now deployed throughout the country by NBR. Throughout this period, the system was scaled up by upgrading of "ASYCUDA World" and fine-tuning of the Oracle hardware and associated software infrastructure, which resulted in marked overall performance improvements.

Oracle along with Local Partner "Spectrum Engineering Consortium (SECL)" helping NBR to manage the Bangladesh's most important Data.

In 2014, NBR embarked on implementing customs tax collection based on the ASYCUDA application. This application allows the NBR to track, collect and estimate the customs duties and VAT. In 2020, NBR completed further enhancement and up-gradation for increased workload and capacity improvement. The current application is running on Oracle x86-based/SPARC Servers for the application and Exadata for Oracle database.







Current IT complexity and future design consideration


Below Engineered Systems has been covered as product discussion topics in 2 days session (21st Sep – 22nd Sep 2022):

- Oracle Engineered Database Platform [Exadata]
- Oracle Database security options

- Oracle Database Recovery Appliance [RA21]
- Oracle universal storage solutions [ZFS]

Product management team of Oracle emphasis on how oracle product and solutions can help NBR to design future roadmap of their digitization journey. NBR already set-up private cloud infrastructure (Including Oracle PCA, Exadata, SPARC, ZFS) with country-wide dedicated data connectivity for their Customs Application. So, it was recommended by product management team to keep the current infrastructure to maintain the growth, performance & scalability as well as consider similar architecture for the other mission critical application of NBR. It would be beneficial to have similar database and infrastructure throughout the organization to have better visibility of the data, single version/model of monitoring system and most important part of smooth data integration. It does not mean every time NBR need to invest full to get the similar architecture benefits what already exist. Rather, existing investment on infrastructure can be scale up to required level with expansion modality where it applicable.

On the other hand, NBR IT team has now proper understanding and visibility of day to day operation and their expertise has been improved significantly in Oracle infrastructure.

Oracle also believe that right customer engagement strategies can have a massive effect on business outcomes. So, in that sessions all product management teams agreed to have special engagement program (product wise) with NBR. Basic plan is to monitor & capture the day to day performance of the Systems for the certain period and make sure NBR has the best experience possible considering product performance scale. Oracle will also do quarterly health checkup of the Systems and recommend if there any options need to be configured or will check important product features whether used or not to have better product/quality bench mark.



NBR also has Platinum support service activated from Oracle. Oracle support team will also conduct a session (probably in End of Oct/1st week of Nov'22) to activate automatic service request feature along with other important notes regarding support services.

In a nutshell, it was a nice session interacting with product owner of Oracle Engineered systems and we received positive feedback from Oracle as they will help & support NBR throughout infrastructure modernization journey. NBR team can reach out to any product management team of oracle for any kind of issues and also can use this channel as escalation matrix of various problems (if required).
