- Ongoing experience within a Customs administration (at least 5 years).
- Proven experience in implementing Customs modernization processes.
- Knowledge of RM and IA.
- > Demonstrated understanding of the latest developments in RM and IA.
- Experience as an advisor, facilitator or mentor.

### 4. Knowledge of WCO Standards and Instruments

- Thorough understanding of the WCO strategies and approach.
- > Robust knowledge of the key WCO standards and tools such as, inter alia:
  - ✓ Customs Risk Management Compendium.
- General knowledge of the key WCO tools and programmes for compliance and/or enforcement such as, inter alia:
