Subject: Exemption of duties and taxes on imports by the United Nations, UN Bodies, Specialized Agencies and U.N. Subsidiary Organisation of the United Nations for their officials Use.

It is hereby clarified that the United Nations, U.N. Bodies U.N. Specialized Agencies and U.N. Subsidiary Organisation are exempt from payment of all kinds of import duties and taxes on imports made for their official use under the Conventions on the Privileges and Immunities of the United Nations, Convention on the Privileges and Immunities of the Specialized agencies, Agreement between the United Nations and the Government of Bangladesh and the United Nations (Privileges and Immunities) Act, 1948 (Act No. XX of 1948) as adapted in Bangladesh.

Therefore, the following organisations are allowed to clear all imports made by the aforesaid organizations for their official use without charging any import duty or tax.
