## SECTION 1 - INSTRUCTIONS TO TENDERERS

### A.GENERAL

<b>1. Scope of Tender</b>	The PROCURING ENTITY named in the Tender Data Sheet ( <u>TDS</u> ) (hereinafter referred to as the “PROCURING ENTITY”) wishes to issue these Tender Documents for the supply of Goods, and Related Services incidental thereto, as specified in the TDS and as detailed in Section 6: Schedule of Requirements.
	The name of the Tender and the number and identification of its constituent lot(s) are stated in the TDS.
	The successful Tenderer will be required to complete the delivery of the goods and related services (when applicable) as specified in the GCC Clause 18.
<b>2. Interpretation</b>	2.1 Throughout this Tender Document <ul style="list-style-type: none"><li>(a) the term “in writing” means communication written by hand or machine duly signed and includes properly authenticated messages by facsimile or electronic mail;</li><li>(b) if the context so requires, singular means plural and vice versa; and</li><li>(c) “day” means calendar days unless otherwise specified as working days;</li><li>(d) "Tender Document ", means the Document provided by a Procuring Entity to a Tenderer as a basis for preparation of its Tender;</li><li>(e) "Tender ", depending on the context, means a Tender l submitted by a Tenderer for delivery of Goods and Related Services to a Procuring Entity in response to an Invitation for Tender;</li></ul>
<b>3. Source of Funds</b>	3.1 The Procuring Entity has been allocated public funds from the source as indicated in the TDS and intends to apply a portion of the funds to eligible payments under the contract for which this Tender Document is issued.
	3.2 For the purpose of this provision, “public funds” means any funds allocated to a Procuring Entity under Government budget; or loan, grants and credits placed at the disposal of a Procuring Entity through the Government by the Bank.
	3.3 Payments by the Bank, if so indicated in the TDS, will be made only at the request of the Government and upon approval by the Bank in accordance with the applicable Loan/Credit/Grant Agreement, and will be subject in all respects to the terms and conditions of that

	Agreement.
<p>4. <b>Corrupt, Fraudulent, Collusive, Coercive or obstructive Practices</b></p>	<p>4.1 The Government and the Bank require that Procuring Entities, as well as Tenderers (including their suppliers, sub-contractors, agents, personnel, consultants, and service providers) shall observe the highest standard of ethics during implementation of procurement proceedings and the execution of contracts under public funds.</p> <p>4.2 The Government and the Bank require that Procuring Entities, as well as Tenderers and Suppliers (including their suppliers, sub-contractors, agents, personnel, consultants, and service providers) shall, during the procurement proceedings and the execution of contracts under public funds, ensure:</p> <ul style="list-style-type: none"> <li>(a) strict compliance with the provisions of Section 64 of the Public Procurement Act 2006 (Act 24 of 2006);</li> <li>(b) abiding by the code of ethics as mentioned in the Rule 127 of the Public Procurement Rules 2008;</li> <li>(c) that neither its any officer nor any staff or any other agents or intermediaries working on its behalf engages in any practice as detailed in ITT Sub Clause 4.3.</li> </ul>
	<p>4.2 For the purposes of ITT Sub-clause 4.2 the terms set forth as bellows:</p> <ul style="list-style-type: none"> <li>(a) <b>corrupt practice</b> means offering, giving or promising to give, receiving, or soliciting, either directly or indirectly, to any officer or employee of a Procuring Entity or other public or private authority or individual, a gratuity in any form; employment or any other thing or service of value as an inducement with respect to an act or decision or method followed by a Procuring Entity in connection with a Procurement proceeding or contract execution;</li> <li>(b) <b>fraudulent practice</b> means the misrepresentation or omission of facts in order to influence a decision to be taken in a Procurement proceeding or Contract execution;</li> <li>(c) <b>collusive practice</b> means a scheme or arrangement between two (2) or more Persons, with or without the knowledge of the Procuring Entity, that is designed to arbitrarily reduce the number of Tenders submitted or fix Tender prices at artificial, non-competitive levels, thereby denying a Procuring Entity the benefits of competitive price arising from genuine and open competition; or</li> <li>(d) <b>coercive practice</b> means harming or threatening to harm, directly or indirectly, Persons or their property to influence a decision to be taken in a Procurement proceeding or the</li> </ul>



	<p>execution of a Contract, and this will include creating obstructions in the normal submission process used for Tenders.</p> <p>(e) <b>obstructive practice</b> means deliberately destroying, falsifying, altering or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede an investigation into allegations of a corrupt, fraudulent, coercive or collusive practice; and/or threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation.</p>
	<p>4.3 Should any corrupt, fraudulent, collusive, coercive or obstructive practice of any kind come to the knowledge of the Procuring Entity or the Bank, this will be dealt with in accordance with the provisions of the Procurement Guidelines as stated in the TDS in combination with ITT sub-clause 4.5.</p>
	<p>4.4 If corrupt, fraudulent, collusive, coercive or obstructive practices of any kind is determined by the Procuring Entity or Bank against any Tenderer (including its suppliers, sub-contractors, agents, personnel, consultants, and service providers) alleged to have carried out such practices:</p> <ul style="list-style-type: none"> <li>(a) the Procuring Entity shall exclude the concerned Tenderer from further participation in the concerned procurement proceedings;</li> <li>(b) the Procuring Entity and Bank shall reject any recommendation for award that had been proposed for that concerned Tenderer;</li> <li>(c) the Procuring Entity shall declare, at its discretion, the concerned Tenderer (including its suppliers, sub-contractors, agents, personnel, consultants, and service providers) to be ineligible to participate in further proceedings of the concerned Procurement, either indefinitely or for a specific period of time;</li> <li>(d) the Bank shall cancel the portion of the loan allocated to a contract if it determines at any time that representatives of the Procuring Entity or of a beneficiary of the loan engaged in corrupt, fraudulent, collusive, coercive or obstructive practices during the procurement or the execution of that contract, without the Procuring Entity having taken timely and appropriate action satisfactory to the Bank to remedy the situation; and</li> <li>(e) the Bank shall sanction the concerned Tenderer or individual at any time in accordance with prevailing Bank's sanctions procedures, including by publicly declaring such Tenderer or individual ineligible either indefinitely or for a stated period of time: (i) to be awarded a Bank-financed contract; and (ii) to be a nominated sub-contractor, consultant, manufacturer or supplier, or service provider of an otherwise eligible firm being awarded a</li> </ul>

	Bank-financed contract.
	4.5 The Tenderer shall be aware of the provisions on corruption, fraudulence, collusion, coercion and obstruction as stated in GCC Clause 3.
	4.6 In further pursuance of this policy, tenderers, suppliers and contractors, and their sub-contractors, agents, personnel, consultants, service providers shall permit the Government and the Bank to inspect any accounts and records and other documents relating to the Tender submission and Contract performance, and to have them audited by auditors appointed by the Government and/or the Bank.
<b>5. Eligible Tenderers</b>	5.1 This Invitation for Tenders is open to eligible Tenderers from all countries, except for any specified in the TDS. A Tenderer will be eligible if it is a citizen, or is constituted, registered and operates in conformity with the provisions of the laws of that country.
	5.2 A Tenderer may be a physical or juridical individual or body of individuals, or company, association invited to take part in public procurement or seeking to be so invited or submitting a Tender in response to an Invitation for Tenders.
	5.3 Government-owned enterprises in Bangladesh shall be eligible only if they can establish that they (i) are legally and financially autonomous, (ii) operate under commercial law, and (iii) are not a dependent agency of the Procuring Entity.
	5.4 The Tenderer shall have the legal capacity to enter into the Contract.
	5.5 Tenderers and all parties constituting the Tenderer shall not have a conflict of interest pursuant to Rule 55 of the Public Procurement Rules 2008.
	5.6 The Tenderer in its own name or in its other names or also in the case of its Persons in different names, shall not be under a declaration of ineligibility for corrupt, fraudulent, collusive, coercive or obstructive practices as stated under ITT Sub Clause 4.3.
	5.7 Tenderers are not restrained or barred from participating in public Procurement on grounds of execution of defective supply in the past under any Contract.
	5.8 The Tenderer shall not be insolvent, be in receivership, be bankrupt, be in the process of bankruptcy, be not temporarily barred from undertaking business and it shall not be the subject of legal proceedings for any of the foregoing.
	5.9 The Tenderer shall have fulfilled its obligations to pay taxes and social security contributions under the provisions of laws and regulations of the country of its origin.

	5.10 Tenderers shall provide such evidence of their continued eligibility satisfactory to the Procuring Entity, as the Procuring Entity will reasonably request.
	5.11 These requirements for eligibility will extend, as applicable, to Sub-contractor proposed by the Tenderer.
	5.12 A Tenderer that has been declared ineligible by the Bank in accordance with the above ITT sub-clause 4.5(e), or in relation to the Bank's Guidelines on Preventing and Combating Corruption in Projects Financed by IBRD Loans and IDA Credits and Grants, shall not be eligible to be awarded a contract.
<b>6. Eligible Goods and Related Services</b>	6.1 All goods and related services to be supplied under the contract are eligible, unless their origin is from a country specified in the TDS.
	6.2 For purposes of this Clause, the term “goods” includes commodities, raw material, machinery, equipment, and industrial plants; and “related services” includes services such as insurance, transportation, installation, and commissioning, training, and initial maintenance.
	6.3 For purposes of this clause, “origin” means the country where the goods have been mined, grown, cultivated, produced, manufactured or processed; or through manufacture, processing, or assembly, another commercially recognized article results that differs substantially in its basic characteristics from its components.
	6.4 The origin of goods and services is distinct from the nationality of the Tenderer. The nationality of the firm that produces, assembles, distributes, or sells the goods shall not determine their origin.
<b>7. Site Visit</b>	7.1 For goods contracts requiring installation/ commissioning/ networking or similar services at site, the Tenderer, at the Tenderer’s own responsibility and risk, is encouraged to visit and examine the Site and obtain all information that may be necessary for preparing the Tender and entering into a contract for the supply of goods and related services.
	7.2 The Tenderer should ensure that the Procuring Entity is informed of the visit in adequate time to allow it to make appropriate arrangements.
	7.3 The costs of visiting the Site shall be at the Tenderer’s own expense.

### **B.TENDER DOCUMENT**

<b>8. 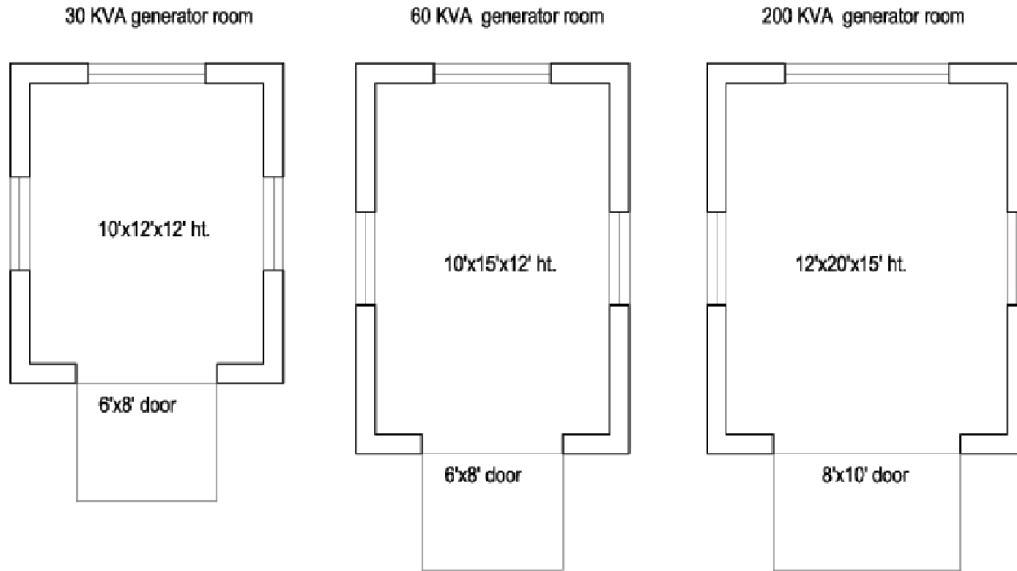
