Notice inviting Application for Training of Trainers (TOT) (Phase-2)

The VAT Online Project envisages different trainings for the NBR Staff for successful implementation of the VAT & SD Act, 2012 and developing VAT administration as a knowledge-based administration. Keeping this in mind, NBR requires development of a skill mass for conducting training programs concerning with the new VAT Law and Rules during the project period even beyond after completion of the Project.

The trainers will conduct all trainings under the project and if indeed, in other areas under the administrative control of NBR.

No need to apply those who have been selected through previous circular.
