 - 12. Logistic capability such as well-equipped office in Dhaka with necessary facilities.
 - 13. Certificates against all the above mentioned conditionalities shall have to be attached with the TDS.

NBR now invites Eligible Applicants to indicate the interest in providing the service. Interested Software Development Firms are invited to provide information indicating that they are qualified to perform the above-mentioned services. This shall require substantiation through submission of brochures and other documents describing similar assignments, experience availability of appropriate professional qualification and experience among applicant's staff, resources to carry out the assignment, financial and logistical capability, etc.

- 1. The Software Development Firm shall provide contract agreement and proof/completion certificate for all the criteria listed above; this should include all contact details about focal point/signatory/contact person.
- 2. The intending firm may associate with other firms to fulfill their qualifications and express their interest JV/Consortium/Associations. The number of JV/Consortium/Associations must be 03 (Three) including the lead firm. Any one firm must be NBR approved VAT software provider. The lead firm must comply with sub-clause 1, 2, 8 & 9 of clause 16.
- Interested Software Development Firms are requested to submit 3 (three) hard copies and 01 (one) soft copy (in flash drive) of the EOI in a simple and clear form which should contain all relevant information.
- 4. The EOI should be submitted with a Table of Contents & Page Numbers both in hard copy & soft copy.

A short list of Software Development Firms will be prepared upon evaluation of EOIs of the eligible applicants and "Request for Proposal" document will be issued in their favor. A Software Development Firm will be selected using the Quality and Cost Based (QCBS) sub-method in accordance with the Public Procurement Act (PPA) 2006 and Public Procurement Rule (PPR) 2008.
